At *Executive Dog Lounge*, we strive to provide your dog with excellent care and a fun experience during their stay. We would like to inform you that while dogs are playing together, they run the risk of certain injuries such as scratches, cuts and sprained joints. Such injuries are rare, but do happen at all doggy daycares. In addition, while very infrequent, dogs can get into fights even under close supervision. At *Executive Dog Lounge*, we screen all dogs for aggressive behavior and we do not allow aggressive dogs to return to the day care. * However, even the friendliest of dogs, from Spaniels to Retrievers, can get into fights with other friendly dogs with very little or no warning. * If your dog is found to be too aggressive and is determined by the team at *Executive Dog Lounge* to pose a danger to other dogs or staff, we will no longer permit your dog into the day care and you may, at management discretion, be refunded any remaining days from the 10 and 20 day packages. Monthly packages paid in advance are non-refundable.

In addition to injuries, it is possible for dogs to transfer illnesses such as upper respiratory infections and canine cough, even with all required vaccinations and boosters.

Parents must know and understand that dogs sometimes do not indicate an injury to us right away, and as a result, you may find an injury when you get home or the next day. When dogs get cuts and scrapes they usually do not start licking the wound until it starts to heal and itch. We pride ourselves on notifying the parents immediately upon finding of an injury. However, parents must accept that it is impossible for any doggy day care to catch every cut, scrape and sprain that occurs during play and is not indicated by the dog.

1. I agree that *Executive Dog Lounge* will not be liable for any claims of injury, illness, damage or death to my dog during its stay and that under no circumstances will *Executive Dog Lounge* be liable for consequential damages.
2. I certify that I have informed *Executive Dog Lounge* of all dog and human aggression. I agree that I am responsible for any harm caused by my dog while in the care of *Executive Dog Lounge*. I shall indemnify *Executive Dog Lounge* against any claims made against it or for losses or damages of suffered by *Executive Dog Lounge* as a result of my dog.
3. I understand that, in the event my dog appears to be ill, injured or at significant risk of experiencing a medical problem, *Executive Dog Lounge* will attempt to contact me for instructions prior to seeking veterinary care. If I cannot be reached, I agree that *Executive Dog Lounge* may use its reasonable discretion in seeking veterinary care on my behalf and that I will be responsible for all related expenses. I understand that *Executive Dog Lounge* will attempt to use my preferred veterinarian, but if my preferred veterinarian is unavailable or other circumstances mandate, I authorize *Executive Dog Lounge* to use a veterinarian of its choice. I agree that *Executive Dog Lounge* will not be liable for the actions and decisions of the veterinarian. I also agree to be responsible for any reasonable fees assessed by *Executive Dog Lounge* for emergency care and transportation.
4. I authorize my veterinarian to share the medical records of my dog with *Executive Dog Lounge* and other veterinarians. I assume full responsibility for payment of all veterinary services rendered, including, but not limited to, diagnosis, treatment, necessary grooming, medical supplies, transportation and boarding. I agree to make such payments directly to the attending veterinarian or agree to promptly reimburse *Executive Dog Lounge* if direct payment cannot be made.

This agreement and waiver is valid from the date below until expressly revoked by written notice and grants permission for future veterinary care without the need for additional authorization each time *Executive Dog Lounge* cares for one or more of my dogs.
